- There has been a big focus on strengthening the organisation and its systems and processes.
- A lot of roles have been contracted instead of employed which reduces overheads and enables us focus on core work and membership.
- Over the past year we delivered four public events, seven micro activations, sponsored the jazz festival, and continued the weekly Sunday Farmer's Market.

- Key focuses next year are producing a strategic plan for the next three-five years and getting an external facilitator to manage it, street cleanliness, lighting and safety, landlord communication and engagement, continuing to grow social media and marketing, and beach and street clean-up events.

Notes to the 2022/23 budget:

- There is a build-up of \$231K that has rolled over. Proposed to spend \$83K of this
 which includes some of the rollover from the previous budget that was not spent.
- Street cleanliness and litter are big issues faced by members and we are working with TCC to improve these issues.
- We need to consider the changes of the new Incorporated Societies Act and review our constitution in line with the changes. Some financial reporting requirements will also change.
- The 2023/24 budget will be presented at the 2023 AGM. The targeted rate will not increase but may increase over time. Breakdown of the targeted rates are available on the TCC website.
- Comments from auditor Richard Dey:
 - o There is an improvement in our set of financial statements.
 - Two sets of audits were completed for 2020-21 and 2021-22 and our financials are now up to date.
 - o The auditors will provide a report on recommendations to the Board.

This would mean an average \$10k increase to the budget across all members year to year. The targeted rates are not being increased yet but it is part of the TCC long term plan that goes to consultation.
